* The current Audit Committee structure includes all Councillors, Council may wish to review whether this arrangement remains effective. In a recent article from the WA Auditor General regarding Local Government audits, it was made clear that this practice, which is operating at a number of local authorities, was not supported by the OAG, the preferred position being that the committee have fewer members.

The Audit Committee can also include representatives from outside Council.

Statutory Environment:

LOCAL GOVERNMENT ACT 1995

5.10 Committee members, appointment of

- (1) A committee is to have as its members
 - (a) persons appointed* by the local government to be members of the committee (other than those referred to in paragraph (b)); and
 - (b) persons who are appointed to be members of the committee under subsection (4) or (5).

* Absolute majority required.

- (2) At any given time each council member is entitled to be a member of at least one committee referred to in section 5.9(2)(a) or (b) and if a council member nominates himself or herself to be a member of such a committee or committees, the local government is to include that council member in the persons appointed under subsection (1)(a) to at least one of those committees as the local government decides.
- (3) Section 52 of the Interpretation Act 1984 applies to appointments of committee members other than those appointed under subsection (4) or (5) but any power exercised under section 52(1) of that Act can only be exercised on the decision of an absolute majority of the local government.
- (4) If at a meeting of the council a local government is to make an appointment to a committee that has or could have a council member as a member and the mayor or president informs the local government of his or her wish to be a member of the committee, the local government is to appoint the mayor or president to be a member of the committee.

- (5) If at a meeting of the council a local government is to make an appointment to a committee that has or will have an employee as a member and the CEO informs the local government of his or her wish
 - (a) to be a member of the committee; or
 - (b) that a representative of the CEO be a member of the committee,

the local government is to appoint the CEO or the CEO's representative, as the case may be, to be a member of the committee.

- *F.1.2 Upon ceasing to be a member of the Council, the representative is to cease as a member of a Committee unless approved by a resolution of Council.*

F.1.3 Upon ceasing to be a member of the Council, the representative is to cease membership of any Regional Council unless approved by a resolution of Council and subject to the Regional Council Constitution.

F.1.4 Council representatives on a committee that is not a Council Committee represent the shire's positions not the individual Councillor's position.

F.1.5 The Council's current committees are as follows;

Setting of a reserve price for the two lots to be auctioned on 23 November 2019 for non-payment of rates.

Background:

At the Ordinary meeting of Council held on 20 February 2018, Council resolved the following;

That Council:

- 1. Exercise the power of sale under section 6.64(1)(b) of the Local Government Act 1995 to proceed to a public auction for the property located at 6 Dowley Street, 27 Robinson Street, 41 Wittenoom Street and 52A Stewart St all of Cue.
- 2. Exercise the power to re-vest the land to the Crown under section 6.74 (1) of the Local Government Act 1995 for the property located at 109 Austin Street and 44 Kinsella Street, in Cue and L66 Boyd Street, Reedy.
- 3. Should the public auction be unsuccessful then move to sell the property via private sale.
- 4. Any amount in excess of that required to clear the legal costs and rates be applied to other costs associated with the original claim.
- 5. In the case that the sale amount is insufficient to cover the rates arrears and legal costs that the amount in excess of the rates arrears and legal costs be written off.
- 6. Authorise the CEO to finalise this transaction.

While this process has taken some time, the Shire has taken possession of the properties at 52A Stewart St and 6 Dowley St and has scheduled to auction both properties on 23 November 2019.

The following is a list of those properties and the total outstanding rates and charges owing against them.

It is proposed that Council set a reserve for the properties to ensure that a reasonable price is obtained for the sale with the option for Council to advertise the land for sale if the reserve is not met or have the land transferred to the Local Government.

Comments:

The setting of a reserve for the sale of the properties will ensure that the Shire will recover some of the outstanding charges on the properties with the option for Council to have the land transferred to the Shire of Cue if a reasonable price is not reached at the auction.

Statutory Environment:

Part 6, Division 6, sections 6.63 to 6.75 and Schedules 6.2 and 6.3 of the Local Government Act 1995 (the Act) and Part 5 of the Local Government (Financial Management) Regulations 1996 (FMR) regulations 72 to 78 and Forms 2 to 7.

6.71. Power to transfer land to Crown or to local government

- (1) If under this Subdivision land is offered for sale but at the expiration of 12 months a contract for the sale of the land has not been entered into by the local government, it may by transfer, where the land is subject to the provisions of the Transfer of Land Act 1893, and by deed, where the land is not subject to the provisions of that Act, transfer or convey the estate in fee simple in the land to
 - (a) the Crown in right of the State; or
 - (b) the local government.
- (2) When a local government exercises the power referred to in subsection (1)(a) in relation to any land all encumbrances affecting the land are, by virtue of this section of no further force or effect against that land and the Registrar of Titles or the Registrar of Deeds and Transfers, as the case requires, is to give effect to this section.
- (3) When exercising the power referred to in subsection (1)(b) the local government is required to pay the sum secured by, or payable under, a

mortgage, lease, tenancy, encumbrance or charge in favour of the Crown in right of the State or a department, agency, or instrumentality of the Crown in right of the State.

(4) Schedule 6.3 has effect in relation to the exercise of the power referred to in subsection (1).

6.73. Discharge of liability on sale of land

A sale of land by a local government or a transfer or conveyance of land to the Crown or a local government under this Subdivision discharges —

- (a) the land; and
- (b) the owners (present and past) of the land,

from any liability to the local government for rates, service charges or other money due to the local government which were, at the time of the sale, transfer or conveyance —

(c) secured by a charge over the land; or

(d) otherwise recoverable, whether under this Act or another written law, by the local government in respect of the land.

Financial Implications:

Once the properties are sold under the Local Government Act 1995 provisions, all charges owed to the Shire will be discharged requiring the write off any amounts outstanding not covered by the sale price. Total combined charges owing against the properties are currently \$23,661.79 and auction fees amount to \$2,945.00.
