Background:		
Comments::		

In consideration of the Shire of Cue's Long Term Financial Plan with a rates increase of 5%, the latest statistics for CPI Perth of 1.0% and the Local Government Cost index forecast for 2017-2018 of 2.0%, it is recommended that an increase of 2.5% be applied to the rate in the dollar for all rate categories with the exception of GRV Commercial and GRV Mining and Transient Workforce Facilities.

It is proposed that the GRV Commercial rate be increased to the same rate as the GRV General rate and then a discount equivalent to the previous discount rate in the dollar be applied to commercial properties. This discount is subject to the property owner paying their rates in full and on time. The discount rate to be applied is proposed at twenty percent.

It is proposed that the GRV Mining and Transient Workforce Facilities rate be increased to the same rate in the dollar as the UV Mining rate. This is to partly compensate for the loss of revenue from the revaluation of the Crosslands mining camp due to a number of buildings being removed from the property and to reflect the increase in maintenance and service costs attributed to these facilities.

Due to changes in rateable values from revaluations and changes to mining tenements the proposed rates will provide the Shire with a total of \$59,202 in additional rates revenue after the commercial rate discount is applied. This is a nominal increase of 2.6% of overall rates. The loss of the licensing concession as of July 1 2017 will increase licensing costs for the Shire by approximately thirty six thousand dollars or 1.5% of rates revenue. Once this is taken into account the increase in rates revenue for operations is only 1.1%.

The proposed rates result in the rates model below.

Objects and Reasons

Where council intend to impose differential rates, it is required to provide the objects of and reasons for each proposed rate and minimum payment. In the notice of intention to levy rates, Council is to advise electors and ratepayers of the time and place where this document can be inspected. The Objects and Reasons for the 2017-2018 rating proposal is attached at *Appendix 3*.

In accordance with section 6.33(3) of the Local Government Act, Ministerial approval will be required for the above rating proposal as the highest proposed differential rate is more than twice the lowest proposed differential rate.

In accordance with section 6.35 of the Local Government Act, it is proposed that a single minimum rate be imposed across all rate categories.
