FROM THE DESK OF THE CEO

The Tourist Park being packed to the rafters is a sign that the season is in full swing. Welcome to all the visitors to Cue. I have been receiving a lot of positive feedback about recent improvements and the general presentation of town which is very gratifying and confirmation that the Shire workers are doing a great job.

One of the recent additions to our town facilities is the bowling green installed next to the Shire Hall. While there is a small amount of landscaping left to complete the project, the green is open for use. The Shire intends to organise a weekly corporate bowls competition and will be calling for expressions of interest, however in the meantime anybody interested in having a roll is welcome to join in the scroungers at 1pm every Sunday. For those who don't have their own bowls, there are a few sets that can be loaned.

As this publication is going to print, final preparations are being put in place for the Cue premiere of *The Decadent & Depraved*. This traditional Western-style movie is set in the late 1800s and was filmed at various locations in WA including Cue. Several Cue residents had roles as extras in the movie and the screening has been keenly anticipated.



Filming of the movie *The Dust Walker* has recently been completed in Cue, injecting tens of thousands of dollars into the local community. The movie now moves into post production, which is expected to be completed in the first quarter of 2019.

Members of STORMCO (Service To Others Really Matters Company) are once again visiting Cue to present their school holiday programs. While in town, the STORMCO crew are volunteering their time to undertake several projects for the benefit of the community. The effort put in by this group over many years has been outstanding.

The Shire's works crew have recently completed sand sealing of additional sections of the Beringarra-Cue Road in conjunction with the Colas Group. The crew has been very busy repairing potholes and reconstructing sections of the road prior to sealing to improve the serviceability of the road well into the future.

Contractors for Main Roads WA will shortly be commencing resurfacing of the main street through town after an unexpected delay. Traffic will be restricted to one lane while the existing surface is removed, with traffic controllers in place for the duration. Works are expected to continue for several weeks.

The process of preparing the Shire budget for the new financial year is well underway, with Council proposing to maintain the rate in the dollar at the same level for most rate categories, apart from mining property rates which will experience a reduction of 1.9%. Overall, the total rates expected to be raised to support the 2018/19 budget will rise by a modest 1.1% due to an increase in property valuations.

The Annual General Meeting of the WA Local Government Association will be held at the Perth Convention and Exhibition Centre during the WA Local Government Convention in the first week of August. Representatives from councils across the state will discuss issues of state wide significance for the local government industry. Councillors Ross Pigdon, Les Price, Ron Hogben, Ian Dennis and Liz Houghton will attend.

Keep your diary free for 3 August when the Shire will present *A Boy Named Cash* at the Shire Hall as part of a state wide Community Arts Network tour. Johnny Cash impersonator Monty Cotton will showcase the greatest hits from the Man in Black.

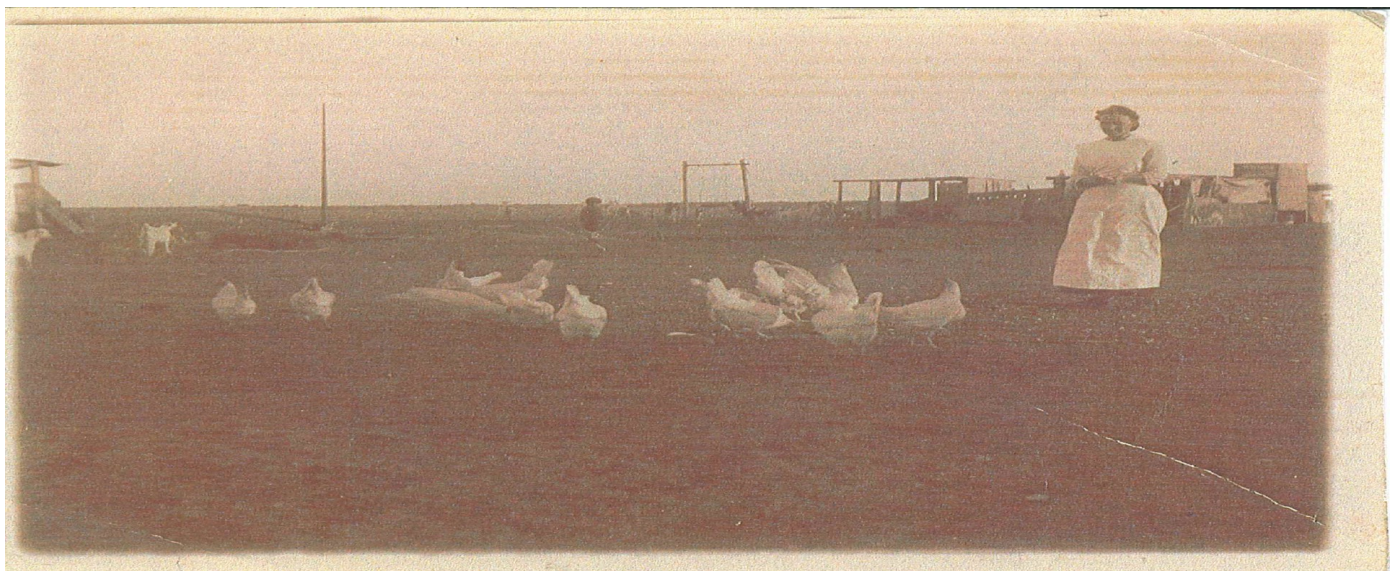

John W. Thompson went to WW1 after moving to Day Dawn before going to war he ran a local shop in the town of Day Dawn.

Jack Thompson had a carrying business in Yalgoo and made many deliveries to stations as well as their daughter violet, Violet did truck runs sometimes when she was the age of 17. Jack had a loving wife named Pearl. Both Jack and Pearl can be seen in the Yalgoo History book.



John and Georgina married in Yalgoo Western Australia on the 5th of June 1899 and have been happily married ever since, they first moved to Day Dawn during 1909 and had 6 children in total . Winfred E. Thompson was born at Cue on the 8th of March in 1903, Olive M. Thompson was born at Mount Magnet on the 19th of March in 1905, Wilfred M. Thompson was born at Mount Magnet on the 1st of September 1907, Joyce D. Thompson was born at Day Dawn on the 29th of March 1914, John and Helda Thompson was born in the city of Perth.



Murder at Day Dawn

On January 5th 1908, Mr William John Clinton's body was discovered at the bottom of an 80ft mining shaft in a town known as Day Dawn. Before his murder Mr Clinton was last seen accompanied by three men; James Potter, George Bloomer and Henry Smith. A statement was received by James Potter explaining that he arrived at Day Dawn on January 9th and was met by his brother, George Bloomer and Henry Smith. James Potter claimed he received a letter explaining that Mr Clinton was threatening to cut the throat of Mrs Clinton, who was also James Potter's sister.

James Potter went with Henry Smith and George Bloomer to confront William Clinton. Mr Clinton beckoned him outside and asked James Potter where he had received the information. He explained he had received the information from Henry Smith who was also a good friend to Mr Clinton. Thrown off by the information given, Mr Clinton was infuriated. It was not the first he had witnessed Henry Smith's betrayal. Mr Clinton claimed he had allowed Mr Smith to come live with him because they were always on the best of terms and would be easier financial wise. One night Mr Clinton went around the back of his home and noticed while walking through the back door Henry Smith with his arms around Lil's (Mrs Clinton) waist. It infuriated Mr Clinton but he admitted he was not cunning enough to do anything at the time. Instead, he thought it would be a good idea to come back to the house one or two nights while on night shift and if he had seen anything else, he would have "settled" both of them.

A statement by George Bloomer was also read; on January 3rd he claimed he discovered Henry Smith groaning and crying and when asked what was wrong Henry Smith replied "I'm thinking of Lil and Viney, I wish they were up here now, I'll get them up here when I get Clinton out of the road and we will get work together." Some days before this George Bloomer stated he went to the post office with him and saw Mr Smith receive a letter addressed "H. Gwynne". Later, while Mr Clinton and James were talking Henry Smith was sat on the bed and began to groan and said "it's killing me. I won't last much longer. I do love Lil and dear Viney. But if I go you can tell them."

Early in the morning of Sunday, January 6th Mr Bloomer was awoken by a report but was dosing off again when he smelt powder. Henry Smith poked him in the ribs and awoken him a second time, "I've settled him" Mr Smith said. Mr Bloomer heard Mr Clinton groaning and woke James and told him about it. Henry Smith turned to James Potter and said "I've settled him. I could not stand it any longer. It was the devil's hand that guided me. The man didn't deserve to live." After realising what was the result of a careless act James Potter and George Bloomer gave themselves up to the police.

Henry Smith gave evidence and claimed George Bloomer was not in the room when the shooting took place, nor was James Potter. He thought he was shot about quarter to five on Sunday morning. He stated Mr Clinton had attacked him with a hammer, he grabbed the rifle and during the struggle it went off and shot Mr Clinton. In regards to the place and time of death they had evidence of Mr Smith, Mr Potter and Mr Bloomer and evidence such as tracks of blood etc. As to the cause of death, they had medical evidence and the confession of Henry Smith. Regarding the accidental or intentional part of Mr Clinton's death they must give consideration to all the facts, such as Mr Clinton's disappearance, the statements by Mr Smith against Mr Clinton. Mr Smith threatening Mr Clinton's life, his connection with Mr Clinton's wife, the secret disposal of the body, the burning of the

telegram sent to Mr Clinton, the preventing of Mr Potter seeing Mr Clinton, telling Mr Bloomer to bring the iron bar from the house and waiting to intercept Mr Clinton

Henry Smith stated he shot Mr Clinton at about 5:00am and Mr Bloomer stated he was awakened by the report. Creating the scenario to be unlikely that there was a physical disagreement between Henry Smith and William Clinton before the shooting, medical evidence and marks from the bullet showed that Mr Clinton was lying in a horizontal position when shot and the shot was fired from a higher position than the body. Henry Smith stated that to his knowledge the shooting took place after Mr Bloomer entered his room and went to sleep and admitted that Mr Bloomer was not in the room when the shooting occurred, apparently two hours later Mr Smith went into Mr Clinton's room and shot him. He would not say anymore regarding the part Mr Bloomer had taken.

The jury had the evidence that Mr Bloomer and Mr Potter had a dolly –bar at a place near Mr Clintons house and were going to intercept Mr Clinton. However, it happened that Mr Clinton was with a Mr Hall and whatever may have been done the weapon was not used at that time. The evidence shows that there was a certain amount of suspicion attached to both Mr Bloomer and Mr Potter in connection with the weapon and that they intended inflicting serious injury on Mr Clinton. If they would have any serious intention it might be interfered that such intention was later on abandoned due to the disagreement in the house and the difference between Mr Potter and Mr Clinton being amicably settled. As far as he could see there was no evidence to make James Potter an accessory, George Bloomer on the other hand he was more closely associated with Henry Smith and had assisted Mr Smith with the cleaning and disposing of Mr Clintons body. More evidence was still yet to point to James Potter and George Bloomer, as regards to Henry Smith all the evidence was strong against him and all the evidence pointed to Mr Smith having wilfully shot Mr Clinton. The jury retired at half past 10 o'clock, an hour later returned with the following verdict; "we find that the deceased, William John Clinton came to his death while lying on his bed at his residence at Day Dawn on January 5th 1908 between the hours of 2am and 5am by a bullet wound wilfully inflicted by one Henry G. Smith. And that the other two prisoners arrested on suspicion, James Potter and George Bloomer were not accessories before the fact"

Before the murder

A married man, employed as a blacksmith's striker at the Great Fingal Mine. William Clinton had not been seen since Saturday night; he was scheduled to work a shift on Sunday but did not put in an appearance. This did not cause comments to be made but when he did not make an appearance for his Monday shift it caused suspicion and inquiries were to be made as to his whereabouts. Based off claims and statements that he had domestic troubles with his Wife and having also remarked that he was going to have a row with two others with whom he was also working on the Klondyke Mine, immediately foul play was suspected. The police were contacted notified. Soon afterwards tracks were discovered 150 yards from where Mr Clinton lived and were easily be able to track themselves to the mouth of the mine shaft. The tracks were made by two individuals and it appeared as if they had dragged something and thrown something down the shaft. At the bottom of the shaft about 80ft deep was found the body of Mr William Clinton partially covered with dirt. The head was badly smashed and a bullet wound in the throat.

It practically began about five years ago, when William John Clinton and Lavinia S Potter were married. It appeared they lived happily enough together, although Mr Clinton was not in regular work which made it hard for the couple financially and his wife was made to support herself. Three months after marrying there was a child, Viney, who is mentioned a great deal in the investigation of the crime. 12 months before Mr Clinton was left for work and arranged to send Mrs Clinton as soon as he made a home for her. They corresponded regularly and Mr Clinton having settled at Day Dawn sent for his wife during the end of October. Mrs Clinton and the children then moved to live with Mr Clinton and they lived in the house where the tragedy was perpetrated.

Shortly after the arrival of Mrs Clinton, Mr Clinton and Mr Smith took up the Klondyke Mine and began to work it, at the end of November William Clinton suggested Henry Smith to live with them at Mr Clintons house, a few weeks later George Bloomer (Mrs Clintons step brother) arrived and also stayed at the house. Three weeks after Henry Smiths arrival at the Clintons home Mrs Clinton and the children went to Perth

Mrs Clinton claimed she went to Day Dawn about two months before that Christmas and lived with her husband at a camp across the line. Later her husband brought Mr Smith to the house and introduced him as a friend of five years. They arranged to work a show and Mr Clinton wanted Mr Smith to stay with them but Mrs Clinton objected to the idea. Mr Clinton however said he would send her back to Perth during the hot weather and if Mr Smith came to the house they could batch when she went away. She agreed and about a week later her step brother George Bloomer also came to the house to live. Mr Smith used to take her eldest child about and wanted to adopt her but she refused and he husband said she was foolish. She and her husband had quarrels but she knew how to cope and manage. Mr Smith never took part in the domestic quarrels but he sympathised with her and said it was not right for Mr Clinton to treat her in such a way, as she was not well.

As Mrs Clinton's departure they all went to the station to see her off to Perth, shortly after arriving in Perth she received a letter from Henry Smith addressed to her in her maiden name. It was signed "H. Gwynn." She then burnt the letter and denied ever receiving it. The letter was mostly to do with the little girl and £1 was enclosed for her. She then received another 7 letters from Mr Smith with another enclosing £1 inside but Mrs Clinton did not reply. Her brother George then wrote to her asking why she was not replying to Mr Smith's letters, she then wrote to Mr Smith and notified him letting him know she had received the money. Mr Smith then wrote back and asked to have the child sent back to Day Dawn but she replied with a response saying that she would have to see Mr Clinton first.

Mrs Clinton had about four letters from Mr Smith and they wrote back under assumed names, because she denied to writing any at all. She had not known Mr Smith before going to Day Dawn she had no conversation with Mr Smith about divorce, but he said to her it was a wonder she had lived with her husband after the way he treated her. He never paid her any attention and had never put his hands around her waist. Mr Smith was sometimes in the camp while her husband was away and that was why she denied Mr Smith being there.

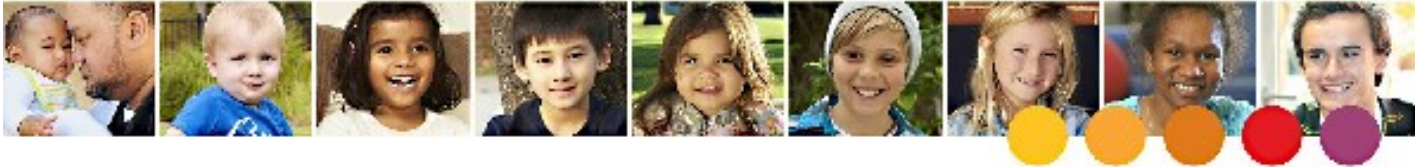
It was a lie.

While Henry Smith was at the house Mrs Clinton said she heard Mr Smith say while taking the child out "This is my child" but she did not think he meant anything by it.

Mr Smith had cross examined and came to the conclusion her husband had an ungovernable temper but that was her business. On one or two occasions he had come home under the influence of alcohol, he never threatened to cut her throat but he said he had something in the house that could do the job if she did not do as he wished. Mr Smith claimed he took the child about because she was smart and also because Mr Clinton swore around her. A witness claims that he saw Mr Smith at the Gribbles Hotel in Cue discussing and borrowing a rifle, claims also reported that Mr Smith was seen interacting and discussing with the same person he bought the rifle from respecting Mrs Clinton on the 31st of December. Mr Smith then told the witness he could not eat since the little girl had gone away and said he was worried and expressed he did not like the way Mr Clinton doesn't behave as he should around the young girl. More conversations came up and Mr Smith told the witness he was heard calling Mr Clinton a "mongrel" and the way he treats his wife is disrespectful, he also said "he's talking about clearing out and when he does she will have a good clean divorce and they'll be nothing stopping her from getting it and then ill marry her" witness said "you ought to be careful or you'll put yourself in a mess, you should not interfere between man and wife." Mr Smith went quiet and made no reply a few moments went by Mr Smith then said "I'll tell you something I have never told anyone else. I am the father of that girl." Witness said, "And you stop in that man's house! You must be a queer man" he had seen the child with Mr Smith and had been told by him that it was Mr Clintons.

Regional Visit Report

Newman, Meekatharra, Cue, Mount Magnet and Moora

25–29 March 2018

Commissioner's comments

In my recent visit to Newman, Meekatharra, Cue, Mount Magnet and Moora I met many young people who were passionate about making their communities a better place for all.

The young people I met with from the schools I visited in the Pilbara and Mid West spoke positively about their communities and the people supporting them, recognising the uniqueness of their local environment and their sense of community. They also were clear on the issues affecting their towns, particularly the accessibility of facilities and organised sport and caring for the environment. The young people I met with also spoke about their desire to help families who were struggling.

I encourage local community decision makers and service providers to reflect on the views of children and young people in their communities outlined above, and continue to explore ways to include children and young people in decision making, particularly around the services and infrastructure that they need.

In every community it was apparent that many children and young people are doing well. However I also heard concerns about smaller groups of children and young people who are seriously affected by disadvantage and family dysfunction.

There needs to be continued effort to collectively address areas of disadvantage within communities and to ensure that programs supporting children and young people are working in an integrated manner to achieve the best possible outcomes for children and young people.

I will endeavour to use these insights to accurately inform government and the community about what we need to do to strengthen children and young people's wellbeing in these communities.

I thank everyone who took time to meet with me and discuss local children and young people's wellbeing.

What the Commissioner heard from children and young people in Meekatharra, Cue and Mount Magnet

Good things about the Mid West included:

- The towns are small so you know everyone and where everything is, the freedom of being able to walk around town.
- Going out bush, especially with family, and all the local wildlife.
- Local parks, skate parks and pools (where the pools were affordable for entry) and "no school, no pool" programs that give you access to the pool for attending school.
- Time spent playing with pets after school.

Things that they would like improved were:

- Facilities at the local pools, including water slides/water features and access to water parks/facilities in towns that didn't already have a pool. One suggestion in Cue included adding a flying fox/tree rope to swing into the dam.
- Having organised sports to make the most of local facilities and engage children and young people more. Suggested sports included football, basketball, soccer and netball for both boys and girls.
- Sun protection covers/indoor facilities were important to young people so that places would be accessible and safe in the heat.
- Having local further education opportunities like TAFE and apprenticeships, and pathways into employment, instead of having to go to Geraldton or Perth away from family.

What the Commissioner heard from children and young people in Moora

Good things about Moora included:

- The smaller schools so you get to know everyone and small town meaning you can walk around.
- The sense of community in town where everyone supports each other and is friendly and welcoming.
- The large number of organised sports for young people to get involved in.
- The opportunities for excursions through the schools and hostel.
- The local swimming pool.
- For students at St James College, their positives included supportive and caring staff who helped to make the hostel a family-like environment, taught socialisation and life skills and assisted with homework, sporting commitments and participation in the community.

Mr Catania highlighted the success that the Nationals “Where the bloody hell are you, Labor?” campaign is having on focussing attention on the disconnect experienced by regional centres like Shark Bay, Monkey Mia and Camarvon when trying to attract attention and funding from the McGowan Labor Government.

“This is a fantastic collaboration between Rex Airlines, the Shires of Shark Bay and Camarvon who are all working to provide cheaper airfares that will undoubtedly deliver greater tourist visitation and help to lower travel costs for businesses in those towns.”

“It highlights the lack of any regional tourism policy from the McGowan Labor Government and its focus on delivering un-costed subsidised airfares for the benefit of only one regional destination at the expense of all the others, essentially pitting regional centres against each other.”

“I would imagine that the “Where the bloody hell are you, Labor?” campaign recently announced by the Nationals WA has had a significant impact on discussions to capitalise on the current discontent from regional centres”, Mr Catania said.

The McGowan Labor Government recently announced that it would be embracing a package of un-costed, subsidised airfares in a secret deal with Qantas to deliver more tourists to Broome, highlighting their lack of innovation when approaching state-wide regional tourism growth.

Mr Catania said “Mark McGowan needs to stop hoping for regional businesses like Rex Airlines to do all of the heavy lifting without investment from his government because they are solely focussed on filling the hotels in Perth and partying with the celebrities they pay to pose on social media with cute, furry animals.”

“It’s obvious from the decision by Rex, Camarvon and Shark Bay that they are tired of waiting for the McGowan Labor Government to engage and invest in promoting regional WA, offering cheaper, fairer airfares to all regional centres like a government who is governing for the whole State would.”
