From the CEO

The Shire has now officially opened the gym facilities for the community to enjoy the benefits through annual or monthly membership. We have a number of suggestions from our "Name the Gym" competition and hope to announce a new name in the next edition of the Dryblower.

A number of Councillors, staff and I attended the WALGA annual Local Government Convention. This year's event had over 650 delegates, from around the State. The conference provided attendees with a great opportunity to network with other Councillors and Shire staff to discuss common problems/solutions facing Shires. We also had updates from the State Government and the sector on emerging trends and potentials threats and opportunities facing Local Governments.

The convention included the Mayors and Presidents Forum, Welcome Drinks and Local Government Awards, Heads of Agencies Breakfast, the WALGA Annual General Meeting, Gala Cocktail Function and Convention Breakfast with keynote speaker Layne Beachley and Kirk Pengilly.

It's that time of the year again!!! The Christmas Light Competition is open for 2024. Please see details in this edition of the Dryblower. Remember to fill in your registration and return to the Shire Admin Office to be eligible for prizes.

Preparations are underway for Australia Day 2025, and it will be another spectacular event with live music and fireworks. We were successful in obtaining grant funding again this year through National Australia Day Council. More details will be provided closer to the event.

The Shire will be holding a short Remembrance Day Service on Monday 11 November 2024 commencing at 10.45am. It will be held at Arthur Stanley Gurney Park, Austin St Cue (next to the Shire Admin Building).

WA Seniors Week runs from 12 to 19 November to recognise the important role that seniors play in our community and acknowledge the contributions of older Western Australians. On Monday 11 November at 12.30pm we will celebrate Seniors Week with a luncheon at the Cue Community Resource Centre. Bookings are appreciated for catering purposes by contacting Tracy at the Shire office. Please let us know if you require assistance to attend the event.

The Murdoch University Vet Program was held on Friday 25 October at the Shire Hall. Students from the University provided free pet checks, sterilisation and microchipping under the guidance of three senior vets. We had 16 animals sterilised, and 29 animals were checked by the students. The program was again a great success. Thank you to Peter Smith from Canine Control for organising this again and ensuring everything ran smoothly on the day.

The Department of Fire and Emergency Services will be undertaking controlled burning within the Cue Town site with a focus on the creek line that runs parallel to Stewart St between the Light Industrial area and the residential area.

The Shire working in conjunction with the Department of Fire and Emergency Services will be undertaking fire break works around Cue town site. Owners and occupiers of land are reminded of their obligations to clear and maintain fire breaks over the summer months.

The summer months are a time of storms and cyclones. Residents are reminded to clean up and remove any unwanted or loose items from their property that could cause damage in a storm. Larger items can be collected by contacting the Manager of Works and Services to make arrangements.

Dog owners are reminded of their obligations to keep their dogs contained within the boundaries of their property or on a leash while walking. Please be considerate of others as it can be quite confronting to be approached by an unknown dog while out walking. The Shire Ranger visits the area frequently and will take action against unrestrained dogs in public places. This may result in a financial penalty to the owner. The only authorised area within the townsite where dogs are permitted to be exercised off-leash is the town oval. It is your responsibility to control and look after your pets.

Mosquito fogging operations are being undertaken when weather conditions allow. Residents are asked to check their properties and remove any potential mosquito breeding areas, by emptying containers holding water, ensuring gutters are not holding water and checking yards for areas that hold water.

We ask everyone to be vigilant as the warmer weather brings out snakes in and around town. Please use caution when out walking. Keeping grass short and cleaning up around the yard will help to keep them away.

Hi 'Dryblower' Readers,

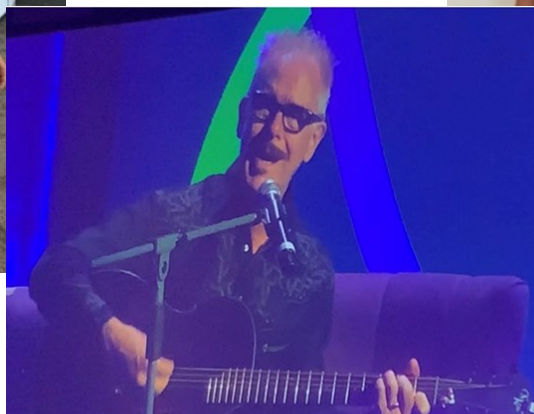
Your Council and the Shire Administration continue to work together to carry out the various programs we hope will be of benefit to our community in the years that follow .

October was again a busy month particularly as our Councillors, the CEO and some Shire staff attended the 2024 Western Australian Local Government Association ('WALGA') Convention. The Convention was held at the Perth Convention and Exhibition Centre from 8th to 11th October.

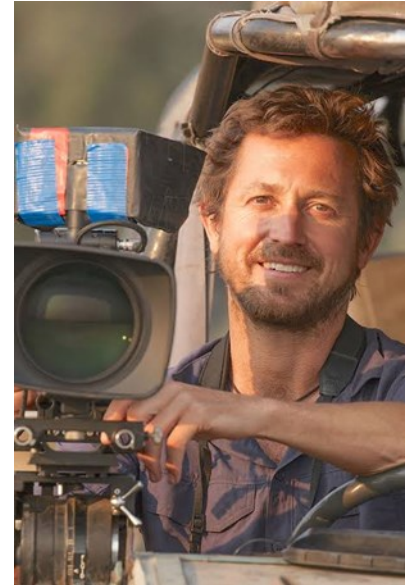
The annual convention provides an opportunity for representatives from all 139 WA Local Governments to meet, network, attend the Annual General Meeting and learn about the current Federal and State Government developments that can and do impact our local communities. The event also included a trade exhibition centre where WALGA's preferred suppliers were given the opportunity to promote their plant, equipment and machinery and goods and services to Local Governments.



Our Shire is always looking to invest in the best of technology and ensure that our plant and equipment is modern and in good working order. During the exhibition I had the opportunity to attend several of the exhibitors' areas with the Manager Works & Services, John ('JC') Curtin. I learned very quickly how knowledgeable JC is in all areas of machinery, plant and equipment which our Shire currently utilises and that which we hope to purchase in the future.



In addition, the Convention was presented with Keynote speaker, Dr. Chadden Hunter who is a wildlife filmmaker, environmentalist, adventurer and Sir David Attenborough's right hand man in the production the Planet Earth series.



On 7th October I attended WALGA's Strategic Planning/State Council Workshop. WALGA is looking to develop its corporate and strategic plan for the next 5 years. Planning is critical in all areas of Local Government particularly in a world where the rate of change is accelerating. The meeting brought to our attention that we are living in the time of 'VUCA' *VOLATILITY - UNCERTAINTY - COMPLEXITY - AMBIGUITY*. Because of this new and unpredictable environment, it is almost impossible to predict threats or opportunities - at the same time, the potential for disruption is very high. Your Council has in place a robust and complete corporate business plan to see us over the next five (5) years. In saying that, our Shire is always ready to review our Strategic Plan should the circumstances change.



I attended a Mayors and Presidents Forum on 8th October. The Forum presents leaders of Local Government with an opportunity to engage and exchange views on issues facing each of our Local Governments. Some of the issues discussed included:-

- Cost of Living
- Housing
- Environment/climate change
- Immigration
- Road funding.
- Cost shifting on to Local Governments.
- Accessing grants.
- Increased funding for regional Local Governments.
- National Disaster relief.
- Increase in Federal Assistance Grants (FAGS)

The Forum also discussed various issues likely to be part of the State 2025 Elections. One of the most significant concerns for all ratepayers is the cost of living. I listen to both Federal and State politicians talk about the issues, however long term solutions appear very difficult to find. In the meantime, Immediate Government relief is a positive step.

The CEO and I had the opportunity to attend the Heads of Agency breakfast on 9th October. My focus at the meeting with Department of Energy, Mines, Industry Regulation and Safety ('DMir's) was to engage with the Department with a view to looking at moving the Great Fingal Mine Office into Cue.

This has been a long standing Council project centred on a building that has both heritage and mining significance. We will keep you posted on any developments.

Following the meeting of 3rd September with the Hon. Hannah Beasley MLA Minister for Local Government and Youth, and the Minister Assisting the Minister for Training and Workforce Development and representatives from the Department of Local Government, Sport and Cultural Industries, WALGA organised a further meeting which was held 11th October. The CEO and I both attended this meeting. The purpose was to identify the most significant issues facing our smaller Local Governments which include:-

- Housing.
- Medical Services.
- Renewable Energy.
- Waste Management.
- ICT Systems and Software Requirements.
- Audit Fees.

The Minister has expressed a desire to work with Band 4 Local Governments to identify the areas of concern and look to provide some solutions. The wheels of Government work very slowly but we are hopeful that our collective voices have been heard.



Westgold Resources Ltd held a Community Forum on the 14th October at the Town Hall followed by a BBQ and sausage sizzle. Whilst I was unable to be at the forum, I thank Councillors Houghton, Dennis and Humphreys for attending and representing the Council. I would also like to thank Bonnie Mason from Westgold's head office for reaching out and engaging with the Community. It is important that we as community have constant dialogue with the mining companies that operate within our Shire boundaries. We also like to thank Westgold for their contributions to our Community and willingness to be an effective and responsive corporate citizen.

Councillor Dennis and I attended the Murchison Regional Vermin Council ('MRVC') meeting in Mt. Magnet on 16th October, along with representatives from Yalgoo, Sandstone and Mt. Magnet. The MRVC has been in operation since 1963 and remains an effective Council in the control of wild dogs. The prime function of the Council is to construct and maintain vermin proof fencing which currently covers approximately 1,007kms through our MidWest region. The current focus of the Council has been to seek approval from the Minister (Hon. Hannah Beasley MLA Minister for Local Government) to convert the Council to a Regional Subsidiary. The main reason is to reduce operational costs of the Council, minimise audit costs from the Office of the Auditor General ('OAG'), reduced financial reporting compliance and thereby minimise the financial burden on our member Councils. One of the other advantages of a Regional Subsidiary is that positions on the MRVC are open to any person within the Shire and are not limited to those persons being required to be a Shire Councillor.

Cue Shire Council held its monthly meeting on 22nd October. The significant matters considered include:-

1. WALGA's advocacy position on the Local Government Act reforms. The Local Government Amendment Act 2023 introduced a range of electoral reforms that came into effect prior to the 2023 Local Government ordinary elections. Some of the electoral reforms introduced were simply not workable for smaller Local Governments. Council has been asked to provide feedback on WALGA's advocacy position in relation to Local Government Elections.

1. Development Application - Workers Accommodation Lot 609 Dowley Street, Cue. Council considered and approved a request to modify the Planning Approval for workers accommodation units on Lot 609 (23) Dowley Street, Cue

On 23rd October I attended WALGA's Municipal Waste Advisory Council ('MWAC') meeting where all things waste is discussed. The disposal and the recycling of waste around the world has become a significant issue and we in Cue are not immune from the impacts of the storage and recycling of waste.

1. WALGA is looking to advocate to broaden the Container Deposit Scheme to include a wider range of products which would include wine and spirit bottles and larger sizes of currently eligible containers.
2. WALGA is also advocating to maintain a resource recovery target of 85% for eligible containers and a focus on litter reduction.

As chair of WALGA's Environment Policy Team I attended an Agenda briefing with Executive Manager of Policy Nicole Matthews on 28th October. The major issue under discussion included:-

- Native Vegetation Clearing Permits.
- Protect and preserve agricultural lands.
- Renewable energy facilities.
- Advocating to improve DMIRS and DWER approval processes

The follow up Environment Policy Team meeting held on 30th October discussed the above matters as well as other environmental concerns facing Local Governments across the State.



I Hope you find the Council article of interest as we do our best to keep you informed on what's happening in the Local Government sector. Your engagement with our Councillors is important if we are to progress the issues you consider important to our town, out residents and ratepayers. Please feel free to contact any of your local Councillors to discuss any matters you consider are of importance. We like to hear from you.

I hope you all continue to be informed of some of our regular Council activities and any feedback is most welcome.

Also, a timely reminder that 11th November is Remembrance Day. Spare a little time at 11.00am to reflect on what our service men and women gave up so that we could enjoy the freedoms we have today.

SHIRE OF CUE FIRE RESTRICTIONS

Prohibited Burning Period

15th December to 31st March

STRICTLY NO BURNING

Restricted Burning Period

1st October to 30th April

PERMITS ARE REQUIRED

Firebreaks should be maintained for the whole of the restricted period.

SHIRE OF CUE FIRE RESTRICTIONS

TOWNSITES

On or before 1st October all town lots within the town sites of Cue and Tuckanarra are required to be treated as follows;

Where the area of land is less than 3,000m², the property must be cleared, mowed, slashed to a MAXIMUM height of 7.5 cm of all flammable material.

Where the area of the land is 3,000m² or more, a firebreak must be provided not less than 3 metres in width inside and along the whole of the external boundaries of the properties owned or occupied and all flammable material must be cleared a distance of 2.7m from all buildings and/or haystacks situated on the land and maintained free of such material until the 30th April.

FUEL STORAGE AREAS

On or before the 1st October all grass and similar material is to be cleared from such places where drum ramps are located and where drums, empty or full, are stored and such areas to be maintained cleared of grass and similar flammable material.

FARM BUILDINGS AND UNATTENDED ELECTRIC MOTORS AND HAY STACKS

Fire breaks at least 3 metres in width completely surrounding and not more than 20 metres from the perimeter of any building, group of buildings or haystacks, All flammable material must be removed from an area 2.7 metres in width immediately surrounding the building. All flammable material must be removed from an area 3 metres in width immediately surrounding an unattended electric motor site.

UNATTENDED FUEL OPERATED MOTORS

All flammable material must be removed from an area 3 metres in width immediately surrounding an unattended fuel operated motor whether the motor is intended to be used or not.

RURAL LAND

Firebreaks must be provided not less than 3 meters in width inside and along the whole of the external boundaries of the properties owned or occupied: where this is not practicable the firebreaks must be provided as near as possible to, and within, such boundaries.

BARBEQUES AND INCINERATORS

Gas and electric barbeques are permitted any time. Solid fuel barbeques and incinerators are PROHIBITED on days of VERY HIGH FIRE DANGER or above.

PENALTY

The penalty for failing to comply with this notice is a fine of up to \$5,000 and a person in default is also liable, whether prosecuted or not, to pay the cost of performing the work in this notice, if it is not carried out by the owner or Occupier by the date required by this notice.
