From the CEO

It's hard to believe that it's the third month of 2025 already. I took time off in January to escape some of the heat and spend some time with my family. While I was away, I attended the funeral service for Dr Kelvin Matthews, former Chief Executive Officer for the Shire of Meekatharra. There was a large representation from the Murchison Region at the service that reflected the interesting life he lived.

A number of Councillors engaged in a field trip to the Day Dawn, Great Fingall Mine operations for a tour of the mine site. The purpose of the visit was to see and discuss with Westgold staff the use of a disturbed section of the old Day Dawn Town Site for use as a Run of Mine pad for upcoming mining operations and expansion of the current waste dump site that sits over part of the old Day Dawn Town Site.





The Annual Meeting of Electors was held on Tuesday 11 February at 5.30pm in the Council Chambers. The minutes from this meeting are published on our website www.cue.wa.gov.au. A small turnout of electors attended the meeting and discussions were held on the disruptive behaviour that is affecting residents in the town.

This led to the calling of a community meeting which was held on Friday 21 February. Over fifty residents attended this meeting to discuss a range of steps and programs that can be explored to engage with and educate the youth to help prevent further incidents of disruption to residents and property. It was a constructive meeting that I felt was the most engaging and attentive from the residents of Cue in my time here and I thank everyone for their input.

The Shire of Cue, Cue Primary School and Westgold met with the Carey Right Track Foundation following the Community meeting to discuss programs for the youth both at school and part of the Youth and Community Centre. Other topics discussed at the Community meeting included dogs wandering the town, overcrowding of housing and blocking of pathways.



With the hot weather in February, the Shire utilised this time to undertake a number of training courses for staff in areas of traffic management, first aid, vehicle operations as well as cyber security and Corporate wellness.

Changes to legislation have made Superannuation for elected members optional for small shires like the Shire of Cue. The council will get the opportunity to discuss and vote on this in the coming months.

Fenix Newhaul are progressing with their expansion and commencement of their Beebyn W11 project with additional worker accommodation expected to commence in Cue in the coming months and additional haul trucks running from Weld Range in the coming year.

Council has resolved to undertake the 2025 Local Government Election by postal vote and have engaged the WA Electoral Commission to facilitate the election.

A number of road work projects are underway in and around the Shire. Works are ongoing on Dalgaranga Road, Wilgie Mia Road and Beringarra Road. Much awaited flood damage repair works are scheduled to start in the coming month as well. Road users are reminded to slow down through road work areas and obey all traffic directions.

The hot weather can bring out snakes in and around town. Please use caution when out walking. Keeping grass short and cleaning up around the yard will help to keep them away.

Dog owners are reminded of their obligations to keep their dogs contained within the boundaries of their property or on a leash while walking. Please be considerate of others as it can be quite confronting to be approached by an unknown dog while out walking. The Shire Ranger visits the area frequently and will take action against unrestrained dogs in public places. The only authorised area within the townsite where dogs are permitted to be exercised off-leash is the town oval. It is your responsibility to control and look after your pets.

Mosquito fogging operations may be undertaken when weather conditions allow. Residents are asked to check their properties and remove any potential mosquito breeding areas, by emptying containers holding water, ensuring gutters are not holding water and checking yards for areas that hold water.

DEPOT TRAINING



This month, the Depot Crew immersed themselves in a nonstop training schedule, where they acquired new skills, faced challenges, and fostered even greater teamwork. Despite the heat, everyone persevered, thanks to the outstanding trainers and the positive atmosphere they created. We would like to thank Ross and George from the Kalgoorlie Tafe, Josh from Stark training, and Jeff from Geraldton Regional for providing us with their skills and expertise. From hands-on practical work to informative theory sessions, the team walked away with plenty of new knowledge and plenty of stories to share.



PLANT TRAINING

They commenced with plant training, which covered several key aspects: reviewing the Safe Work Method Statement (SWMS), pre-start checks for machinery, effectively calculating load weights, discussing risks and hazards, understanding what to anticipate on a worksite, and performing civil construction tasks using the skid steer, loader, excavator, and tractor. The process went smoothly, the workers that were already certified were eager to share their knowledge and assist their colleagues through it all.



WHITE CARD

Upon finishing the plant training, they proceeded with their white card training. This course equipped them with essential knowledge and skills to ensure safety on a construction site. The training covered various topics, including:

- Occupational health and safety
- Identifying hazards and risks present on the site
- Strategies to minimize those hazards and risks
- Emergency procedures and first aid
- Safe work practices, including the use of personal protective equipment

Additionally, they learned about their responsibilities as workers in promoting safety on the job site and gained insights into the requirements of communication and reporting.



TRAFFIC MANAGEMENT

The depot team has successfully obtained their Basic Worksite Traffic Management (BWTM) and Traffic Controller (TC) certifications. This course equipped them with both theoretical and practical skills necessary for installing and maintaining traffic management signs and devices at various worksites and events, along with performing manual traffic control on-site using a stop/slow bat.

FIRST AID

The final course to be completed was the first aid training. Although the course demanded considerable concentration, the team approached it with enthusiasm. They were determined to acquire the essential knowledge to uphold the safety and standards of the community.



FINISHED FOR THE MONTH

The month had strengthened team bonds through engaging activities, laughter, and shared stories, making the experience both enjoyable and memorable.

This training was not just a requirement; it was a chance for personal growth and a step toward a brighter future. The depot crew finished, feeling motivated, equipped with new skills and a renewed sense of purpose.

Council News

Hi 'Dryblower' Readers,

Welcome to another edition of the 'Dryblower'.

Local Governments across WA have been very busy during the course of the 2024 year and sometimes the expectations from ratepayers, the business community, the demands from State and Federal Governments and of course the management of Shire Administrations can be taxing. Councillors who represent their Local Governments work tirelessly, a lot of which is not always visible to the community.

January each year is a time when a holiday beckons or presents the opportunity to take some time out. Other than our Australia Day celebrations on 26th January it was a quiet time for Councillors. Albeit that 26th January has come and gone I do need to pass on some positive comments I received from some people from neighbouring towns who attended our event, enjoyed a nice BBQ and were impressed at the effort Cue had gone to put on a fireworks display. We even had some positive comments from one truckie who regularly cruises through Cue on his way to Newman that the night scene was spectacular as he passed through. He said it was as if he hadn't missed Australia Day celebrations after all!

Now that we are back in working mode, February saw the beginning of a busy year ahead. On 5th February I attended the WALGA State Council Information Forum. With a State and Federal Election looming CEO Nick Sloan identified the key issues WALGA will be concentrating on. These include:-

- Health
- Road Safety
- Infrastructure
- Clean energy
- Climate Change
- Cost of Living

The CEO gave an overview of the State and Federal Election Priorities and said that WALGA is monitoring the priorities of all major parties to see where it should focus its media attention. WALGA has been undertaking political engagements, social media connectivity and programmatic access through radio, paid media and the West Australian and Sydney Morning Herald newspapers to bring the focus on Local Government issues. ALGA is also using its influence at the Federal Level.

We in the regions are aware that our population base does not give us a loud voice and added to reduced political representation, we rely on WALGA to be that voice for its Local Government Members.

December 2025 saw some significant changes to the Local Government Act which will impact Councils and the Administration. The Tranche 2 reforms were assented to by the WA Parliament on 6th December 2025.

Some of the many changes include:-

- Reforms to Roles and Responsibilities- Local Law reforms - Conducting Reviews- Committees of Council- Owner and Occupier roll changes.
- Planning and Building Performance. Local Government is slowly losing its powers over Planning.
- Establishment of an independent Office of the Local Government Inspector and Monitor. Superannuation for Elected Members

On 11th February Councillors, the CEO, Richard Towell, EA, Janelle Duncan and Shire Councillors met with Westgold Resources Ltd.'s General Manager, Simon Waters and Dean Caporn, Manager Environmental, to discuss Westgold's activities at the Great Fingal Mine, Day Dawn. Councillors undertook a field trip to inspect some of the areas Westgold is considering accessing in and around the old Day Dawn Townsite. This followed an earlier meeting on 23rd January with Westgold by Cr. Ross Pigdon, CEO Richard Towell and I.

On 11th January the Cue Shire Council held its Annual General Electors Meeting. Ratepayers and residents alike are encouraged to attend the Electors Meeting and participate in discussions on the direction our Shire is taking. Immediately, following the Electors Meeting the Shire Council held its monthly Forum where Councillors were briefed by the CEO Mr. Richard Towell, Mr John Curtin, Manager Works and Services and Senior Administration Officer, Stephanie Wandek on the current and upcoming activities of the Shire. The Forum provides Councillors with an opportunity to have informal discussions with the Administration around, projects, grant funding, roadworks and finances.

On 12th February Councillor Ian Dennis and I attended the Murchison Regional Vermin Council ('MRVC') ordinary meeting and an Audit Committee Meeting in the Mt. Magnet Shire Council Chambers. The 'MRVC' continues to be an active Council in the control of wild dogs with the construction and ongoing maintenance works on the No 1 and No 2 Vermin Fences.

On 18th February an Audit Committee Meeting was held to consider the 2024 Audit Report of the Cue Shire of Cue, and it was recommended that the Report be accepted and put to Council at the next ordinary meeting. At the Shire Council Meeting held following the Audit Committee Meeting Council:-

- Accepted the Audit Committee's recommendation to Council that it adopts the 2024 Compliance Audit Return; and
- adopted the 2024 Compliance Audit Report as presented.

The next Local Government ordinary election will be held on 18 October 2025. The Shire of Cue will have three Councillor positions become vacant.

- Council declared that, in accordance with section 4.20(4) of the Local Government Act 1995, the WA Electoral Commissioner to be responsible for the conduct of the 2025 ordinary election together with any other elections or polls which may be required; and
- Decided, in accordance with section 4.61(2) of the Local Government Act 1995 that the method of conducting the election will be as a postal election.

On 19th February I attended WALGA's Metropolitan Waste Advisory Council Meeting ('MWAC'). Topics discussed included the local waste law review, the 2025 Waste and Environment Summit, waste recovery, hazardous and e-waste, landfill, product stewardship, the circular waste economy along with a discussion on the proposed waste levy.

On 27th February I met with two representatives from the Department of Energy, Mines, Industry Regulation and Safety ('DMIRS') who are currently conducting a review of the abandoned minesite area within a 1km radius of the Cue Primary School. The Department is looking to undertake a project of ensuring that any abandoned sites are made safe. There will be more on this project over the next 12 months.

On 27th February The CEO and I travelled to Mt. Magnet to attend Local Government training delivered by WALGA. The training was well attended by Councillors and CEO's from Mt. Magnet, Yalgoo and Cue and was delivered by Mark Chester, a now retired and experienced Local Government CEO. With so many changes to the compliance obligations on CEO's and Councillors it is mandatory to continue to upskill and undertake training.

The final issue of *The Murchison Times and Cue - Big Bell - Reedy Advocate* was published in March 1942, marking the end of a newspaper series that began with *The Murchison and Day Dawn Gazette* in 1894. It was renamed *The Murchison Times* in 1924 before adopting its final title in 1937.

Since its inception in 1894, the paper's publication schedule varied. Initially printed twice a week, it increased to three times a week in late 1896. In 1914, it reverted to twice-weekly editions before shifting to a weekly format in 1916.

The first edition, *Vol. 1, No. 1*, was printed and published on 15 August 1894 by James Thomson, sole proprietor of *The Murchison Times and Day Dawn Gazette*, in Cue, Western Australia. By the newspaper's final years, printing was conducted for Geraldton Newspapers in Geraldton, with publication continuing under *The Murchison Times* name in Cue.

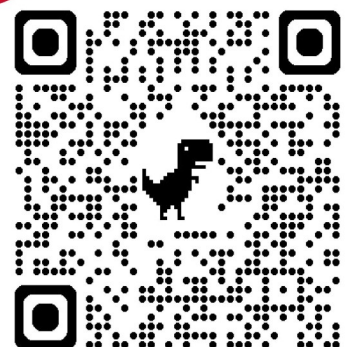
